2. On April 1, 2017 the Company has adopted the India Accounting Standard ('Ind AS') notified by the Ministry of Corporate Affairs with effect from April 1, 2016. Accordingly, the financial results for the quarter ended June 30, 2017 have been prepared in accordance with Ind AS and other accounting principles generally accepted in India and the results for the comparative quarter ended June 30, 2016 have been restated in accordance with Ind AS. The financial results for the quarter ended 30, 2016 have been review or auditor and are compiled by the management after exercising necessary due diligence to ensure that theses give a true and fair view of the Company's affairs.
3. Considering the nature of the Company's business and operations, as well as based on reviews performed by chief operating decision makes regarding resources allocation and performance management, the Company has reorganized its operating segments and has classified Trading and Manufacturing as separate operating segments, in addition to earlier reported segments. During the quarter, after considering the above reorganization, the Company has identified Trading and Manufacturing as reportable segments in accordance with the requirements of Ind AS-108 " Operating Segments"
4. Reconciliation of results between previous reported (referred to pervious GAAP) and Ind AS for the quarter ended June 30, 2016 is presented as below:


