The financial results for the quarter ended 30, 2016 have been review or auditor and are compiled by the management after exercising necessary due diligence to ensure that theses give a true and fair view of the Company's affairs.
- 3. Considering the nature of the Company's business and operations, as well as based on reviews performed by chief operating decision makes regarding resources allocation and performance management, the Company has reorganized its operating segments and has classified Trading and Manufacturing as separate operating segments, in addition to earlier reported segments.
