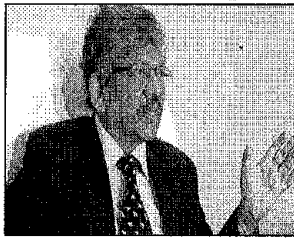

देहरादून। चुनावक स्तरीय भती परीक्षा में पेपर लीक मामले के बाद आज उत्तराखंड अधीनस्थ सेवा चयन आयोग (एफएसएसएस) के अध्यक्ष एस राजू ने अपने पद से इस्तीफा दे दिया है। उन्होंने पेपर लीक मामले में धंधली को लेकर मैजिस्ट्रेट के आदेश पर इस्तीफा दिया है। वे 2016 से चेयरमैन के पद पर तैनात थे। सितंबर में उनका कार्यकाल समाप्त होने वाला था। बता दें कि इससे पहले अधीनस्थ सेवा चयन आयोग के अध्यक्ष रहे आशीष रायत ने भी 2016 में पेपर लीक विवाद के बाद पद से इस्तीफा दे दिया था।

एस राजू ने कहा कि उनके कार्यकाल में आयोग ने अब तक 86 परीक्षा कराई हैं। जिसमें से दो में गड़बड़ी सामने आई। पहले फॉरेस्ट गार्ड भती परीक्षा में धंधली सामने आई थी। तब भी



स्तरीय परीक्षा गत वर्ष सितंबर में करवाई थी। इसमें बाद से ही लगातार इसमें धंधली की बात सामने आ रही थी। भीती 22 जुलाई को मुख्यमंत्री के निर्देश पर रायपुर आने में मुकदमा दर्ज किया गया। तब इसकी जांच एसटीएफ को सौंपी गई। इसके बाद ही एसटीएफ करिवी जोड़कर पूरे मामले की जांच में जुटी है।

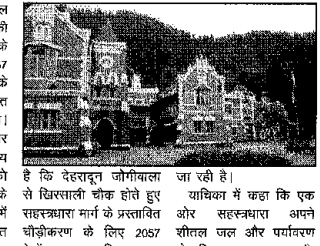

देहरादून। नैनीताल हाईकोर्ट ने देहरादून की सहस्रधारा रोड चौड़ीकरण के लिए 2057 पेड़ों के प्रस्तावित कटान के खिलाफ दायर जनहित याचिका पर सुनवाई की। कोर्ट ने पेड़ों के कटान पर रोक लगा दी है और राज्य सरकार सहित अन्य को जवाब दायित्व करने के निर्देश दिए हैं। मामले में अगरी सुनवाई 17 अगस्त को होगी।

मुख्य न्यायाधीश विपिन सांघी एवं न्यायमूर्ति आरती सुखले की खंडपीठ में देहरादून निवासी और समाज सेवी आशीष गर्ग की जनहित याचिका पर सुनवाई हुई। याचिका में कहा गया

# 331 नए कोरोना संक्रमित मिले, एक मरीज की मौत, 237 हुए ठीक

देहरादून। उत्तराखंड में कोरोना संक्रमण की रफ्तार लगातार बढ़ रही है। चार दिन से प्रदेश में 300 से ज्यादा मामले सामने आ रहे हैं। शुक्रवार को भीते 24 घंटे के भीतर प्रदेश में 331 नए संक्रमित मिले हैं। जबकि 237 मरीज ठीक हुए हैं। वहीं, एक मरीज की मौत हुई है। सक्रिय मरीजों की संख्या भी 1800 से ऊपर पहुंच गई है। प्रदेश में मिलेहाल 1836 कोरोना मरीजों का इलाज चल रहा है। जबकि गुजरात को प्रदेश में 1748 सक्रिय मरीज थे। स्वास्थ्य विभाग के मुताबिक शुक्रवार को 2221 सैम्पल की जांच रिपोर्ट

मिगेटिव आई है। वहीं, देहरादून जिले में सबसे अधिक संक्रमित मरीज 20, नैनीताल में 53, अल्मोड़ा में 68, वागेश्वर में दो, घमेली में सदान, चिंतौली में एक, पीड़ी में आठ, पिथौरागढ़ में चार, रुद्रप्रयाग में 34, टिहरी में 11-11 और ऊधमसिंह नगर में 38 संक्रमित मरीज सामने आए हैं। वहीं, प्रदेश की रिकवरी दर 94.31 प्रतिशत और संक्रमण दर 12.97 प्रतिशत दर्ज की गई।

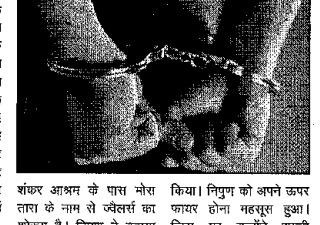

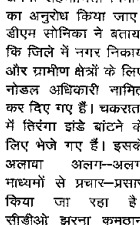

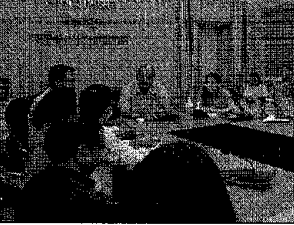

# मंत्रियों ने की हर घर तिरंगा की तैयारियों की समीक्षा

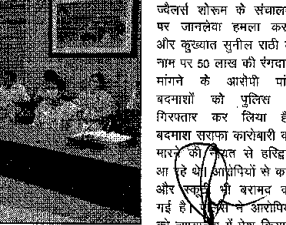

### Thai nightclub fire kills 13 people



**Bangkok, Aug 5 (IANS):** At least 13 people were killed and more than 20 others injured after a fire erupted at a nightclub in Thailand's Chonburi province on Friday, local media reported.

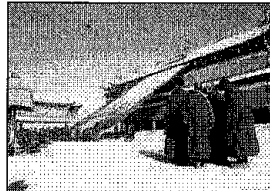
The fire, which broke out in the Mountain B nightclub at about 1.40 am, has been brought under control, and the injured people have been hospitalised, Xinhua news agency reported.

The victims — nine males and four females — were all Thai nationals, said Wisara Petchanai, a rescue worker at the scene with the Singing Bojans Thammathuan Foundation.

### China warns Tibetans not to post birthday wishes online for exiled Buddhist abbot

**New Delhi, Aug 5 (IANS):** China has ramped up restrictions ahead of the birthday of a pre-eminent Tibetan Buddhist spiritual leader, calling on local leaders in two Tibetan regions to prevent people from posting his photo or well wishes online, media reports said.



Authorities have threatened to arrest Tibetans in the Ngaba and Dzogze regions who defy the order by posting messages on August 8, the 80th birthday of the 11th Khyabje Kirti Rinpoche (honourific) Lobzang Tenzin Tigma Yeshe Gyantsuo Rinpoche, RFA reported.

Rinpoche is the chief abbot in exile of the Kirti Monastery, one of the most important and influential monasteries in Tibet, the report said.

"The government has warned of such activity by Tibetans, and individuals will be arrested and severely punished if found defying it," said a Tibetan source inside Tibet who declined to be identified so as to speak freely.

Chinese authorities restricted monks from the Talsang Lhamo Kirti Monastery in Dzogze county and the Kirti Monastery in Ngaba county, both in Sichuan province's Ngaba Tibetan Autonomous Prefecture, from celebrating Rinpoche's birthday in 2021. The areas are heavily populated with ethnic Tibetans.

Monks were not allowed to leave their monasteries, and gatherings were not permitted during that time, RFA reported.

Last year Tibetans inside Tibet anticipated restrictions and scrutiny from the Chinese government on celebrating the 80th birthday of the Kirti Rinpoche, so they held back," said a Tibetan who lives in exile.

"But this year, Tibetans living in exile and inside Tibet are looking forward to celebrating Rinpoche's birthday and offering prayers," the source said, referring to a long-life prayer offering made to spiritual teachers.

### Ukraine intel claims Putin using body double, points to his changing ears

**Kiev, Aug 5 (IANS):** Ukraine's military intelligence chief has revived a theory that Russian President Vladimir Putin is using body doubles — and has pointed at his changing ears over the years as proof, media reports said.

Putin's (69) health has been the topic of fierce discussion among commentators, Daily Mail reported.



His close ally Nikolai Patrushev is said to have stood in for the president during his medical appointments, the report said.

This week, Ukraine's Major General Kyrylo Budanov appeared on TV to claim to viewers that Putin's height and ears have changed in recent appearances, The Sun reported.

He said: "The picture, let's say, of the ears, is different... And it's like a fingerprint, each person's ear picture is unique. It cannot be repeated."

Budanov further alleged that Putin body doubles "have different habits, different mannerisms, different gaits, sometimes even different heights if you looked closely."

Budanov had previously claimed a Vladimir Putin body double may have been used for his arrival at a summit in Tehran last month. While the Russian leader looked awkward as he came down the

steps of his presidential plane in Tehran, Ukrainian sources noted that he moved unusually quickly and was more alert than in prior public appearances, Daily Mail reported.

The Russian premier looked animated when greeting the waiting party, before removing his jacket and clambering into a heavily armoured limousine.

Budanov said he was suspicious of Putin's appearance in a live interview on Ukraine's 1+1 news channel.

Ukrainian reports said Budanov suggested that a Putin look-alike could have flown to Tehran to meet with the presidents of Iran and Turkey.

### Cambodian PM gets honorary doctorate from state-run university



**Phnom Penh, Aug 5 (IANS):** Cambodian Prime Minister Hun Sen on Friday was bestowed with an honorary doctorate of development from the state-run Royal University of Phnom Penh (RUPP), Education Minister Heng Samrin announced.

Samrin presented the degree to him at the ceremony here, attended by his family members and hundreds of high-profile figures, reports Xinhua news agency.

Speaking at the event, Hun Sen expressed thanks to the university for honoring the effort in developing the nation and in serving the people.

### Amid China, Taiwan tension, Nepal's foreign minister to visit China

**Kathmandu, Aug 5 (IANS):** In the midst of rising tension between China and Taiwan after the visit of US House Speaker Nancy Pelosi, Nepal's Foreign Minister Narayan Khadka is visiting China from August 9-11, Nepal's Foreign Ministry announced on Friday.



At the invitation of Chinese State Councilor and Foreign Affairs Minister Wang Yi, Dr Khadka is visiting China from August 9 to 11, the ministry said.

The two ministers will hold bilateral talks, leading their respective delegations on August 10 in Qingdao, China.

Wang will host a banquet in honour of Khadka and the members of the delegation, the statement added.

The visit is taking place days after the Chinese Ambassador to Nepal, Hou Yanqi, issued a statement in Kathmandu over Pelosi's visit to Taiwan, calling it a serious violation of the one-China principle and hailing Nepal's commitment to one-China policy.

"We believe that Nepal will continue to abide by the one-China principle and understand and support China's legitimate and justified position and

work together with China to defend each other's sovereignty, security, and territorial integrity," the envoy added.

After announcing the visit, Nepal's Foreign Ministry said that it is closely following the evolving situation in Taiwan Strait.

"We are closely following the latest developments in Taiwan. We are committed to the one-China policy. Since Nepal is a peace-loving country, we stand for world peace," said Sewa Lamsal, Foreign Ministry spokesperson, on Friday at a regular press briefing.

"Both Nepal and China support each other's sovereignty, territorial integrity, and independence."

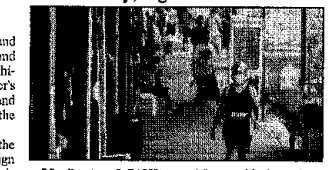

### Philippine inflation accelerates to 6.4% in July, highest since Oct 2018



**Manila, Aug 5 (IANS):** Year-on-year inflation in the Philippines accelerated to 6.4 per cent in July, the highest since October 2018, the Philippine Statistics Authority (PSA) said on Friday.

PSA head Dennis Mapa told reporters that the July inflation was mainly due to higher prices in food and non-alcoholic beverages and transport, reports Xinhua news agency.

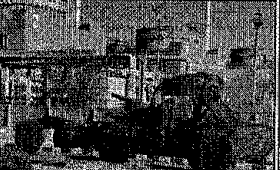
He added that the country's average inflation in the first seven months this year stood at 4.7 per cent.

Mapa said the primary source of the upward trend was the higher annual growth rate in the index for food and non-alcoholic beverages at 6.9 per cent.

The transport index grew by 18.1 per cent.

He said the higher year-on-year increases in the prices of alcoholic beverages and tobacco, 8.5 per cent; clothing and footwear, 2.5 per cent; and furnishings, household equipment, and routine household maintenance, 3.1 per cent, also contributed to the July inflation.

### Russia using nuclear plant as cover to launch rocket attacks



**Kiev, Aug 5 (IANS):** Russian forces at Europe's largest nuclear power plant in Ukraine are employing "terror tactics" by using the site to launch rocket attacks on civilians, media reports said. Russia controls the Zaporizhzhia plant and surrounding areas, close to Ukrainian-held territory.

Western officials have sounded the alarm about Russia's moves there, BBC reported.

The Zaporizhzhia nuclear plant lies in the south-east of Ukraine along the western bank of the Dniipro River. It is currently still being operated by Ukrainian employees under Russian supervision. ### UK 'must take more action on monkeypox or it will become endemic'



**London, Aug 5 (IANS):** LGBT+ groups from across political parties have joined forces to demand the UK government increase efforts to combat monkeypox or risk it becoming "endemic" in the country.

The US on Thursday declared a public health emergency over the virus, which in the majority of the cases seen so far affects gay and bisexual men and other men who have sex with men (MSM), which followed the World Health Organization (WHO) last month calling it a global emergency, reports dpa news agency.

British health authorities have urged calm, but now those inside Westminster have called on

health charities including the Terrence Higgins Trust, said the government must prioritise communication and vaccination.

"We need clear, non-stigmatising messaging, delivered direct to GBMSM about the symptoms of monkeypox and what to do if you suspect you have the virus to inform and reassure people (rather than the current broadcast-to-all approach that constantly mentions GBMSM)," the authors, who included the Tories' Luke Black and Labour's Matthew Lloyd, stated.

"Messaging must reach communities at high risk of acquiring monkeypox, through targeted messaging on apps, online and in the queer media."

The letter, which was also signed by sexual
